## **Centre Visits under Corona Pandemic Conditions**

## Dear FIGU friends and Interested ones

Taking into account the recommendations of Ptaah, the core group has decided that visits to the centre are possible again with immediate effect, but only with the following conditions being adhered to:

- Visiting hours: ONLY on Sundays! In the morning between 9.00 and 12.00 h and in the afternoon between 13.00 and 17.00 h. Outside these times NO visitors will be received.
- Duration of the visit: The duration of the visit is limited to a maximum of 2 hours even for interested ones who arrive from greater distances or from overseas.
- Registration: On our website there is a registration form for a visit, which must be filled in. NO visitors will be received without prior registration via internet or telephone.
- Number of visitors: A maximum of 2 persons per visit will be received, who must belong together and be at least 14 years old.
- Children under 14 years of age: They have no visiting rights even if accompanied by an adult.
   Therefore, do not bring children with you, even if they were to wait outside under supervision.
- Passport: In order to prevent contact data fraud, and due to official controls, an official passport
  must be presented at the beginning of the visit.
- Contact details: Name, address, telephone number and e-mail address must be given at the beginning of the visit. A corresponding form is available.
- Mask obligation: There is a strict mask obligation whereby we only accept the wearing of FFP2 masks or FFP3 masks. FFP1 or homemade masks are not tolerated. If no appropriate mask is used, we will refuse visitors, and also if they do not want to wear a mask, even if they have registered.
- Distance: It is imperative that a minimum distance of 2 metres is maintained. Visitors who do not keep the minimum distance will be immediately barred from the premises, even if they are registered.
- Disinfectant dispenser: It is imperative that the provided disinfectant dispenser is used for hand disinfection at the beginning of the visit. For the disinfection we provide a health-protecting 70% alcohol solution.
- Separation screen: Conversations with visitors will only take place with a separating screen between the visitors and the supporting FIGU members, while the protective mask, however, must still be worn nonetheless.
- Mask disposal: Used masks must not be thrown away outdoors on FIGU premises or elsewhere,
   but must be taken along and disposed of at home in the correct form.
- Animals: There must be no animals (dogs etc.) brought along, even if they were to be tied up outside.
- Signs of illness: In the event of signs of illness, no matter which kind, visits are of course to be avoided, even if the visit has already been booked.
- Cancelling: Even in the case of a short-term appearance of symptoms of an illness, the FIGU must be informed that the visit will not take place.
- Rules of conduct and instructions: The rules of conduct set out in this leaflet must be respected, as well as any specific instructions given by FIGU members.
- Exceptions: No exceptions will be made in any of the points listed.
