Answers to Corona Questions Excerpt from the 765th contact, Wednesday,3rd of February, 2021

Billy ... Here, look at this report, which says that the WHO is now conducting alleged research in China to find the origin of the rampantly spreading corona disease. What they will do, however, on one hand, will be nothing more than pro forma bungling work, as Sfath and I observed it to be in the future, and on the other hand, because they will not find out anything, because they cannot find out anything, they will simply claim mendaciously that the rampantly spreading corona disease originated from bats, only that it cannot be explained how the rampantly spreading disease was transmitted from them to human beings. And if I remember correctly, they claimed that the virus was probably carried by an intermediate host or something and transmitted to human beings.

Ptaah Yes, that is how my father also wrote it down in his annals. As I read in it, you two went back again and again over the whole period of the rampantly spreading disease and also observed how the WHO's carrying out of its alleged clarifications, that is to say, how it will carry them out in the present time in the next few days, was/will be marked by ridiculousness and an unknowledge of the facts as well as an uninformedness regarding research." That the actual origin...

Billy No, please do not, because Sfath said that it should not be talked about, but only the most important things should be said informatively, and that only related to certain information about the necessary behaviour and safety measures, especially with regard to respiratory protection masks and dealing with the fellow human beings. As far as the origin is concerned, that shall not be mentioned openly, as you know.

Ptaah Certain information, however, would be with reg...

Billy No, unfortunately it does not work, because nothing can be changed either way. That which already happened in the future, as observed in advance, is equally true in the present and cannot be changed, just as everything that has happened in the past cannot be changed, because what has already happened cannot be changed. This is the case regardless of whether it is something that has happened in the past or whether it is an event that has been observed to happen in the future and that is now actually occurring in the present as it was observed about 70 years ago to be in the future.

Ptaah It should indeed be possible to provide certain information about that which my father Sfath recorded in his annals relating to that which you two observed at that time and, moreover, it could be helpful in preventing further calamities.

Billy Of course, it could be possible, but that must not be considered, which is why Sfath required me to keep quiet about it, because ... well, I can really only explain that to you in confidentiality.

Ptaah Yes please.

Billy Good, but really only confidentially. - ...

Ptaah ... Yes, ... but, Eduard, ... I am not involved in your confidentiality, therefore I could ...

Billy No, my friend. – You know, Ptaah, even if Sfath has obviously omitted to mention that nothing should be announced about this by third parties, my word of silence, which I gave him, applies to me. And if I have told you one thing or another, then it was because, on one hand, as Sfath's son, you are continuing his work, then ... well, and on the other hand, I only informed you in the confidence that you too, as Sfath's heir, are also bound by the same duties, promises and rules and so forth, which also impose on you the duty to remain silent, because you have somehow inherited all the duties and are continuing them, thus also the silence. That, I think, should...

Ptaah ... I should consider. Well, please let it be, I ... Sorry, ... As old as I have become ..., ..., but what you say, ... yes, it is right. Still at my age I have to be taught, ... But information would be in reg...

Billy Please do not do that, Ptaah, there is no need. You know, I too often feel the need to say more, on the one hand ..., ah, what shall we say about it. It is what it is, and that cannot be changed, and all of that which has happened so far, the whole thing corresponds to the result of the incompetence of all the governments of the world, as well as the approximately 1/3 of the peoples which is made up of those who are trouble-makers, those who stubbornly resist ordinances or deliberately undermine them, know-it-alls and conspiracy theorists of a worldwide rampantly spreading disease catastrophe, as was always the case in earlier times. Thus the whole of the fact that the pandemic could arise at all is, as always, the fault of the human beings themselves, namely the incompetent governors and the 1/3 part of the stupidly-brazen and impudent troublemakers of the populations who are basically to blame for the death of many human beings and who, due to their lack of conscience, do not give it any thought at all.

The absolutely inadequate and confusing things that have happened so far with regard to the rampantly spreading corona disease can be traced back, on the one hand, to the inept governors who have always been incapable of properly combating such crises, such as rampantly spreading diseases, and are still incapable of doing so. To this day, due to low intelligentum (In contact 750, Billy explains, "...these days practically no longer anybody knows that 'intelligence' is only the intellectmemory, but does not describe the cognition and also not the intelligentum, nor the information processing of the human being. That is why the so-called IQ is erroneously and foolishly 'measured' with the intellectual memory, namely with the term 'intelligence' – which we have already spoken about before. This is because 'intelligence' in reality has nothing to do with the 'intelligentum' and thus has nothing to do with intellect, rationality, knowledge and absolutely nothing to do with the extent of knowing the general performance capacity related to the intellectum." Please see contact 750 to understand more.), that is to say, non-thinking, they have never learned to create the right safety measures in accordance with the basic law and the constitution, to take such measures and to have them enforced by virtue of the national constitution with regard to health and safety for the benefit of the people through the deployment of all necessary security agencies and law and order agencies. This is because they are just as incapable of asserting themselves against all the querulousness of the trouble-makers - who, in complete low intelligentum and thus as a result of their inability to think, by means of demonstrations refer to inadequate basic rights and destroy private and state property – as they also cannot assert themselves against the economic mights, the god-believing cults as well as the big and small businesspersons and so forth. On the other hand, however, it is also that part of the population itself, the ones which are of low intelligentum and those who stubbornly resist ordinances or deliberately undermine them, which always amounts to between 20 and 30 per cent, from which always terror is spread and calamity is conjured up, which always leads to many deaths through their fault. But it would be pointless and senseless to go on talking about this. ...

... But listen to this, a telephone conversation which I recorded with this device, but which I will delete again as soon as you have listened to it.

Ptaah ... This too is appalling; therefore it is very good that you have carried out educational work and worked out the need in relation to protective measures against the rampantly spreading corona disease, which have also been checked by your proofreading group and then published by your website managers.

Billy Yes. – The two of us indeed no longer want to talk about corona, which we have decided, but look what I have written here and what will be sent out to all FIGU members worldwide tomorrow and also put on the FIGU website.

Ptaah As I can see there are 7 pages, which is a bit much to read at the moment, which is why I will only look through it briefly and then copy it to read it thoroughly later. ... Yes, Eduard, this is important information that needs to be published and that will be of interest to the human beings who open your website.

Billy On the 23rd of January I presented it to Florena, and on the 26th of January also to Quetzal, both of whom also said that the human beings would need this information. But also have a look at this letter, because someone writes that I should give some more information about the corona vaccination and also some explanations about the respiratory protection masks, but I only know what I remember from Sfath and what I have also still learned on top of it in the present time. Here, too, I have been asked what is to be understood by the 1st, 2nd and 3rd waves of the rampantly spreading corona disease, and what should be done fundamentally to make the rampantly spreading disease disappear. And here the question asked is also about the long-term effects and long-term consequences, as well as what pathogens are and the difference between bacteria and viruses and what micro and nano are. Various other things are also being asked for, because there is obviously a great need for clarification among the populations, but the incompetent governments and experts are obviously not capable of providing the necessary explanations. When you read all the questions that are being asked here, then there really is a great need among the people for some more explanations, whereby, however, it will not be possible to explain everything completely, because everything is too extensive.

Ptaah (reads) ... Amazing these questions and the unknowledge that prevails. Something should effectively still be explained about this, which I will gladly do.

Billy You do not have to, Ptaah, because the questions are addressed to me, dear friend, and therefore I am expected to answer them. But if I cannot handle it, then I can take the liberty of asking you. And it is further to be said that, unfortunately, none of the incompetent governors, virologists, epidemiologists and all other illogical '...logists' of all kinds have any idea that the populations want to be enlightened with regard to all the connections of the rampantly spreading disease in order to understand everything and be able to act accordingly. And since this is not being done, there are many more human beings who follow those who stubbornly resist ordinances or deliberately undermine them, those know-it-alls and conspiracy theorists, who shout about in demonstrations on the streets and cause destruction.

Ptaah Of course. And you should answer the questions, because with that you are not starting something new regarding the rampantly spreading corona disease, which we no longer want to talk about, but you are giving explanatory answers to questions that have been raised.

Billy Good, if you say so. – What I remember is, for example, that Sfath said at the beginning of the 1950s that all kinds of future and light respiratory protection masks – at that time today was still referred to as the future – would indeed protect against certain aerosols and all kinds of bacteria and microorganisms if worn over the nose and mouth. A start for a special and extremely thin primary material of such protective masks, a melting fibre or something, if I remember correctly, which together with another material would be well suited for the production of a good breathing mask, had already been invented in the USA at the beginning of the 1940s. However, this would only be brought together with another material in the GDR in the late 1960s and early 1970s, from which then good protection masks would be made. If I remember correctly, Sfath said that a gossamer synthetic fibre was invented by GDR experimenters, which was then brought together to form a spunbond fabric or something, and the so-called non-woven fabric was made. From this, he said – and I remember this well – good, valuable and useful non-woven breathing protection masks would be made.

Now, as far as respiratory protection masks are concerned that are not attacked by viruses, there are really only good protective masks that should be used in this regard, such as the generally standard FFP2 and FFP3 masks. In general, for daily use, the FFP2 masks without an exhalation valve are actually common and useful, which, according to terrestrial test results, are supposed to be approx. 94% effective in preventing corona viruses from entering the mask and thus the respiratory tract of the human being, although you talk about only 92-93% safety. These FFP2 masks are normally fitted with ear holding rubber bands, while suitable FFP3 masks — which, according to terrestrial data, are supposed to keep 96% and, according to your data, about 94% of viruses from penetrating — also have holding straps for around the back of the head. The extent to which corona viruses can penetrate a protective mask and reach the respiratory tract of human beings, while other pathogens and pollutants are prevented up to 96% from penetrating this quality of mask, depends on the type of mask and the mask quality, whereby FFP2 and FFP3 are the most common half masks, after which only full-face masks and so forth, exist.

The danger with regard to aerosols, however, does not exist in the fact that they are contaminated by viruses and can penetrate from the outside through masks into the interior and thus into the respiratory tract of human beings, because respiratory protection masks of the quality FFP2 and FFP3 can provide good protection against aerosols. The effective danger factor is of a different kind, namely that aerosols contaminated with viruses discharge in the open air, that is to say, they 'open', 'break open' or 'burst open' and thus release the virus. Sfath explained the whole thing to me at the beginning of the 1950s and also let me see on his monitors how aerosols containing viruses burst and the viruses then floated freely in the air, indeed for a very long time and additionally were swirled around in the air by the wind and thus distributed. This fact makes it particularly clear that viruses can also be inhaled through unsuitable masks, because the viruses are x times tinier than the aerosols that are prevented from penetrating good masks.

In this day and age of the rampantly spreading of corona, the wearing of good and tested respiratory protection masks for the sake of health is just as urgently necessary as is keeping one's distance while dealing with other human beings from outside of the immediate family circle. This is contrary to all the lies and misleading assertions of know-it-alls, troublemakers, contrarians, conspiracy theorists and those who – not-thinking and of low intelligentum – insist on basic rights and live under the delusion that curfews would restrict their freedom and only correspond to authoritative terrorist measures. This delusion, however, is complete nonsense, because curfews serve to prevent the spread of the rampantly spreading disease and therewith protect the lives of many fellow human beings.

In today's prevailing corona pandemic time, respiratory protection masks are effectively of urgent necessity and one can no longer imagine being without them, rather they belong in the protection concept of every individual human being who recognises his/her responsibility. And this is necessary both in everyday life at work and also during leisure time, and indeed without exception when dealing with human beings who do not belong to the healthy and closest family circle, whereby a minimum distance of 1.5 to 2 metres from them must also be the rule. And additionally I would like to say the following in particular: wearing respiratory protection masks as a defence against pathogens of the rampantly spreading corona disease corresponds to a duty towards one's own and any other life. Respiratory protection masks generally correspond to half masks that cover the mouth and nose and thus the lower part of the face, therethrough protecting the person wearing the mask from harmful aerosols, toxins, particles and microorganic pathogens that are filtered out by the masks. Such particle-filtering half masks generally correspond to tested products that are commercially available with the designation FFP1, FFP2 and FFP3, whereby FFP stands for 'face filtering piece' and describes masks that are made entirely from filtering material and in such a form that they cover the part of the face from the nose over the mouth to the chin.

If, with regard to the rampantly spreading corona disease, personal responsibility or a legally prescribed obligation to wear a respiratory protection mask is specified, then masks of the FFP2 or FFP3 type should generally be used. These can be used with or without a breathing valve, whereby masks with a valve offer the advantage of easier breathing, but expel the used breathing air through the valve and thus, under some circumstances, also any possible pathogens if the person wearing the mask is ill.

The wearing of respiratory protection masks should not only be an adequate protection and a necessary precautionary measure, but also equally an effective protection for one's own life, as well as for the surroundings and thus for the fellow human beings. Therefore, only breathing masks **without** a valve should be worn. This is because effectively a person wearing a mask with a valve only poses no risk of infection to the environment and other persons if he/she is absolutely healthy and therefore does not breathe out any pathogens through the mask valve.

The personal protection against pathogens should require that fellow human beings and the surroundings are also sufficiently protected; consequently, in the case of rampantly spreading diseases or other contagious diseases, respiratory protection masks with valves should only be used and worn by persons who are either absolutely healthy, meaning that no

pathogens are exhaled through the valve, or who are healthy but have severe breathing difficulties when wearing protective masks.

Basically, in the case of rampantly spreading diseases or other infectious diseases of any kind, not only one's own protection should be taken into consideration, but also an appropriate protective effect for the environment, that is to say, the fellow human beings.

What I already know from Sfath is that simple respiratory protection masks do not protect against the coronavirus because viruses exist down to nanoscale diminutiveness, for which, however, I have forgotten the details and names of the main types of viruses and their sizes. If I make an effort to remember, then I can still bring together that Sfath first spoke of a Pandora virus, also of a herpes virus and of a bacterium and Pano- or Rimo virus or such, as well as of a millionth metre, that is to say, micrometre, as well as of thousand-millionth, that is to say, nanoparticles. But I really no longer remember the numerical values about that, that is to say the size or the tininess.

Ptaah I can help you to remember: the **Pandora virus** has the designation and size $1 \mu m$, that is to say, 1 millionth and can be recognised with an electron microscope.

A **bacterium** has, depending on type, a size of **1-5** μ m = micro- or My or millionth = micrometre, and can be detected with a light-microscope.

A herpes virus has a size of **200-300 nm**, nanoparticles = nanometres and can be detected with an electron microscope. The **coronavirus** is **120 nm** tiny = **nanoparticles**. These are connected with a few to some thousand atoms or molecules, whereby the term 'nano' refers to the tininess, which is 1 to 100 nanometres, whereby one nanometre = $nm = 10^{-9} = 0.000$ 000 001 metres = 1 thousand-millionth of a metre.

A parvo virus, as well as a ribosome, have a tininess of **20 nm = nanometres**.

Billy Thank you. About that I would like to explain that 'nano' is derived from the Greek 'nanos', which is tantamount to 'dwarf' or 'dwarf-like' or, in a better German term it can be expressed as 'winzig' [tiny]. And that which I was able to read about nanoparticles was that according to ISO/TS 27687:2008 – I do not know what that means – nano-objects are particles that have three external dimensions; whatever that means, but that is not important for understanding that nanoparticles are extremely tiny and that simple protection masks do not stop corona viruses, but can therefore penetrate through the masks and be inhaled by human beings. Unsuitable and useless in this respect and offering no protection whatsoever are all self-made

- 1. Fabric masks of all kinds
- 2. Neckerchiefs
- 3. Handkerchiefs
- 4. Face shields of all kinds
- 5. FFP1 masks

Only high-quality FFP2 and FFP3 respiratory protection masks can offer the real, highest possible protection against viruses from the size of 1-5 μ m millionths = micrometres of bacteria down to 'nm', that is to say, nanoparticles. Nu...

Ptaah Excuse me, but for this I want to mention our examination results, which are extremely precise and highly superior to all terrestrial, even highly technical, possibilities in this respect and which are not yet made for exactly precise results. According to our research, cognitions and results, these results show only a 92.6% safety for the FFP2 grade protection masks you mentioned and only 94.3% for FFP3 with regard to a COVID-19 permeability.

Billy Thank you, you have indeed told me this before, which I should also mention, but I just wanted to mention the terrestrial data which supposedly can guarantee 94% safety for the FFP2 masks and 96% for the FFP3, but above all not 99%, as is falsely propagated, thereby misleading the human beings and lulling them into a false sense of security. This is also done with the vaccines, which have not yet really been tested thoroughly and have not been tested for their effective efficacy, consequently these actual and necessary tests are only now being done, and the necessary cognitions are only now being gained, by means of the mass inoculations and the experience to be gained from that. However, this is not disclosed to those willing to be inoculated, just as it is also not disclosed that the effectiveness of various vaccines is lied about and kept secret and that, contrary to alternative deceitful claims, they do not have equally positive effects on all corona mutations. It is also concealed that certain vaccines have no effect at all for certain reasons, which means that inoculated persons are infected with the corona virus regardless of the vaccination and can therefore also die from the rampantly spreading disease.

As far as small and large viruses are concerned, I found this list here, in which it is briefly described which factors influence the size and tininess of viruses, that is to say, how large and small viruses differ. It also lists the factors that also influence the size of viruses – genome (DNA or RNA) proteins, pathogenicity factors on the viral shell – as is written here:

The further questions I can still answer relate to that which we have already stated several times since the emergence of the rampantly spreading corona disease, that the rampantly spreading disease will cause millions of deaths as a result of the incompetence of the governors and the querulousness of about 1/3 of the population as well as the pathological craving for pleasure, travel, feasting, sport and the human being's urge to have to go outdoors from their homes. In this respect, the human beings live thoughtlessly, irresponsibly and senselessly go about their lives, come what may, and do not consider in any form certain precautionary and safety rules that should be observed. But since the incompetent governors are "sick in the same hospital" and can neither think nor therefore know what really has to be done, it follows that they are not role models for the populations, but failures who are copied in the same form.

And regarding the questions here, being what should really be done thereto, in my opinion, there is only strict compliance and the enforcement of inevitable security and precautionary measures, which should not only be observed but should be enforced against all unintellect, all irrationality and all low intellectum (Bernadette as per Billy: The "intellectum" is the entire block of the "intelligentum", therefore it includes the intellect, rationality and knowledge and effectively sits above the intelligentum, while intelligence is the storage of knowledge.) of those incompetent rulers and sections of the population by the deployment of effectively loyal security forces. This would require a plan to be drawn up and followed, which your father Sfath and I had been thinking about, and if this had been implemented at the beginning when the rampantly spreading disease came up, then the rampantly spreading corona disease would have petered away within 2 to 3 months before it was able to get badly out of control and turn into a pandemic. However, I do not want to speak about this plan, because firstly, those authoritative rulers who are self-important, arrogant and might-obsessed do not listen to the concerns of the populations anyway and consequently no plan and proposal is followed, and on the other hand, as a rule, about one third of the populations who are densely of low intelligentum, always cause trouble, therefore that which is necessary and right cannot be implemented, from which the remaining part of the population then has to suffer and accept harm and even death. However, as far as the question of what should be done first and foremost is concerned, there are a few important points which are absolutely essential, which I will mention as follows, the implementation of which would be urgently necessary, but which are not being implemented by the lame rulers and the stupidly-brazen 1/3 of the population:

- 1. The compulsory wearing of suitable respiratory protection masks of the quality FFP2 or, under some circumstances, FFP3, as required, in unavoidable contact with fellow human beings outside the strictly personal living area.
- 2. The compulsory keeping of distance from person to person in unavoidable contact with fellow human beings outside the strictly personal living area.
- 3. 'Lock under', that is to say, strict lockdown, that is to say, total curfew, except for occasions such as: grocery shopping, emergencies and health care related to medicine/doctor, hospital, energy needs, but controlled overall within responsible limits by security agencies.
- 4. Curfew violations by the unteachable ones should be prosecuted with severe penalties and long-term quarantine.
- 5. Absolute strict prohibition of any kind of travel, public entertainment, sporting events, events for pleasure and other non-essential activities of any kind, religious events such as visits to churches, mosques, temples, synagogues and religious circles, and so forth, as well as learning, teaching and school organisations.
- 6. General suspension of work in all enterprises that are not vital for the populations, in accordance with certain extensive regulations concerning the avoidance of financial damage, regulation of rent and lease obligations and so forth.

7. Drafting of fundamental rights laws that are also designed for emergency situations and are to be followed by the populations, such as in crises, epidemics and pandemics, times of emergency, country-wide or world-wide natural disasters and so forth.

As far as the measures regarding curfews and an entire lockdown are concerned, the responsible governments and parts of the populations are completely irresponsible, namely because as soon as the infection situation improves somewhat, lockdowns are immediately relaxed again, wherethrough the whole of the infestation can strike again from the beginning. This is an absolutely idiotic and irresponsible action, which in each case leads to thousands of infections again and costs further thousands of lives. But as long as incompetent governors sit at the helm of the countries, palavering stupidly and imbecilely, hoping for help from an imaginary god and sneaking around the bottoms/backsides of the economically mighty ones and doing what they want, nothing will change for the better and that which is rational. Similarly, nothing will change for the better and the good if the third of the irrational and crazy, stupid-brazen and impudent ones as well as the querulous, know-it-all and conspiracy believers of the population are not stopped and not put off course, who in many cases also spread the rampantly spreading disease further by means of their pathologically imbecilic behaviour. That is one part of the story, but on top of that one is attacked and insulted in a simple-minded form or even taken to court if one speaks the truth about what is really going on and shows how simple-mindedly the ones who stubbornly resist ordinances or deliberately undermine them and the troublemakers behave and act on the one hand, and, on the other hand, how incompetent and short-sighted those in government are and how they have no idea of what needs to be done effectively to counteract the rampantly spreading corona disease properly. In fact, one has to be glad that one is not sued and punished by inadequate laws if one speaks the truth publicly, as is especially the case when I denounce the incompetence, loud-mouthedness and low intelligentum of those in government without attacking any particular government person with insulting nonwords.

Yananara That can probably only be the case if you were personally attacking a person and rudely insulting them, which, however, is not the case if you are just generally, in a decency-maintaining form, showing their inability to govern.

Billy ... To all that which has been said, very extensive statements and explanations would still be necessary, but to list them now would take up too much time; consequently I can only briefly address the 7 points mentioned and not explain them further. I would also like to briefly address the question that is being asked regarding the 1st, 2nd and 3rd waves, because an explanation is obviously necessary, because no...

Zafenatpaneach Ptaah probably told you that we were coming. Greetings, my friend.

Yananara To this I add my voice. Greetings, dear friend. But do not let yourselves be interrupted in your conversation, for we are not in a hurry and want to wait.

Billy Ptaah actually said you were still coming here. Welcome and greetings to both of you. And if you are not in a hurry, I would like to finish what I was about to start.

Yananara Do not let us stop you.

Billy Thank you. – Therefore: when talking about a 1st, 2nd and 3rd wave of the rampantly spreading corona disease, then this is obviously completely misunderstood. Overall, it should be understood that all the individual waves are not several, but effectively only one wave, that is to say, one swell, as is also the case in all freshwaters, streams, rivers, major rivers and lakes, as well as in all oceans. Such a swell occurs depending on the subsurface, the depth of the water, the strength of movement in the case of seaquakes, as in the case of wind and storm lashes on the waters, wherethrough then the very swell occurs which results in a wave sequence that produces asymmetrical waves. This means that a wave difference occurs in the form that different wave sizes arise, which never have exactly the same wave height, because depending on the origin, there is a constant up and down in this respect and, in between, a larger wave can also rise again, namely depending on which movement powers cause the swell. As a rule, this cannot be seen by the naked eye, because human beings generally do not train themselves for such natural phenomena and also otherwise usually walk blindly or half-blindly through the world, do not have an eye open for nature and therefore see nothing.

Well, as with the water swell, the whole thing also occurs with the rampantly spreading corona disease or with other things, because basically it is always the same swell, but not a new wave when one rises again and becomes stronger or bigger and so forth. Therefore it is no more and no less always just the same swell widening further, which, however, from time to time in a single wave becomes higher and stronger again through some circumstances, in order to then collapse again and 'normalise', so to speak. And this is exactly what brings about the same effect with the rampantly spreading corona disease, whereby the becoming of a new wave usually results from the irrationality and wrong behaviour of the human beings by disregarding the protective measures against the rampantly spreading disease.

Yananara It is amazing how you always know how to explain something so that it can be understood.

Billy – If you think so ..., thank you. What I have here now, Ptaah, is something else – an article sent to me by Achim Wolf concerning vaccination against the rampantly spreading corona disease, if you will please skim it briefly:

Ptaah (reading) ... I will really just 'skim' over it because it is a bit extensive, but I will copy it.

That which is being concealed in the vaccination campaign Author Vera Lengsfeld, published on the 29th of January, 2021

Hopes for an early end to social and economic gagging are currently focused exclusively on the completely new mRNA vaccines, as if there were nothing else at all. ComirnatyR has won this race for the time being. With strong motivational slogans such as 'giving perspective for a virus-free future' (SZ 19.1.2021), 'protecting against a deadly infectious disease with one prick' (Cichutek, PEI) or 'we need a vaccination marathon now!' (M. Blume, 27.1.2021), the simple-minded population is solicited for the needle prick they long for. It is particularly perfidious when attempts are made to dupe the elderly with 'We will get vaccinated, but grandma first!' (SZ 23./24.1.2021). This sits well, shows responsibility and altruism. It is the result of wrong information and misinformation!

About the approval:

The mRNA vaccines were approved in the EU by means of CMA (Conditional Marketing Authorisation) for a limited period of one year after an extremely shortened development time. This approval is not a regular approval, but was granted without submission of conclusive data on safety and efficacy against the background of the pandemic Covid-19 situation, dramatized by the manufacturer and numerous other stakeholders. The CMA approval is connected with the obligation to subsequently submit numerous data that is still missing, including cognitions on serious, rare and long-term side effects as well as potential risks. Details of this are contained in the Development and Risk Management Plan (RMP). This is therefore an experimental vaccine that is not yet fully developed and for which further experience must be gained by the end of 2023, provided the vaccine remains on the market until then.

That is concealed in the so-called package information leaflet; the Swiss expert information (22.12.2020) appropriately refers to the 'limited approval with incomplete data'.

About the effectiveness

ComirnatyR has been shown to be 95% effective in reducing PCR-confirmed cold symptoms (sufficient in the clinical trials was the presence of a symptom, such as fever, cough, shortness of breath, chills/rigors, muscle pain, loss of taste or smell, dry throat, diarrhea, vomiting), according to the manufacturer. However, verification of the observed Covid-19 cases (8 in the vaccine group, 162 in the placebo group) and the 3410 suspected cases (1594 in the vaccine group vs. 1816 in the placebo group) by validated methods other than the PCR one, which is inappropriate for confirming cases of disease, did not occur. The individual immunity status was not monitored before or after vaccination. These aspects cast doubt on the validity of the study results.

Incidentally, the observed vaccination success of 0.044% (44 infected/100,000 vaccinated) was only slightly below the threshold value of 0.05% applicable in Germany for triggering stricter protective measures, but above the lowered threshold value of 35/100,000 already under discussion. Whether this vaccination protection is sufficient to protect the population is an open question.

The secondary study objective, reduction of severe disease cases, was not achieved; the effectiveness for severe Covid-19 cases was only 66.4%; the quality of evidence was rated as very low. A reduction of hospitalisations and deaths was not envisaged in the study plan; consequently, no data exists on this. The intended realisation of the vaccination prioritisation goal – prevention of severe COVID-19 courses (hospitalisation) and deaths – thus lacks any basis.

The prevention of the transmission of SARS-CoV-2 as well as the guarantee of protection in environments with high proportions of vulnerable persons and in those with high outbreak potential has also not yet been tested; results on this will most likely not be available until late 2023.

Declaring the very old to be the first to be prioritised for vaccination is not medically justifiable because there is virtually no experience of efficacy and safety in them (>85 years: 5 persons; between 75 and 85 years: 774 to 804 persons). Even trivial side effects, such as diarrhea or a rise in temperature, can lead to a fatal outcome in the case of a generally weakened constitution or bedriddenness, thus increasing the number of persons who die prematurely. The quickly found explanation for this – that these are expectable deaths in old age – is out of the question as long as the very old are promised salvation from too early death and the Covid-19 deaths in old age are not subject to the same interpretation.

Until 17.1.2021, 21 deaths were reported in Germany in temporal connection with the vaccination (RKI). In addition, reports are increasing from nursing homes where vaccination was administered and persons died shortly thereafter (for example, 13 of 40 vaccinated persons in Uhldingen-Mühlhofen). In addition, several unusual Covid-19 outbreaks occurred in nursing homes in connection with vaccination. The Israeli health authorities reported approximately 240 cases of Covid-19 disease

related to primary vaccination as early as January 1, 2021. Such cases are not inexplicable. In addition to common interpretations, such as: full efficacy can only occur after the second dose or probably an infection already occurred before or shortly after vaccination – it should also be remembered that VAED/VAERD (vaccine-associated enhanced disease) can occur, about which neither vaccinators nor vaccinees are or will be informed, although this potential risk runs like a red thread through the approval documents!

In contrast, the involvement of vaccine-induced production of spike proteins, which, like the complete virus, could bind to the cell surface and trigger appropriate subsequent reactions there via the receptor ACE2 (my hypothesis!), remains unclear. It is well known that only the PCR method is used for the evaluation of the epidemic situation in Germany (and worldwide) as well as for the confirmation of cases in clinical trials. And this method is known to be unsuitable because it only detects parts of the virus on cell surfaces, which is why it cannot be used to detect a virus that is capable of replication. It could well be used for supportive diagnostics, provided that the WHO appeal (20.1.2021) to use the test only as a diagnostic tool in accordance with the instructions (use only in connection with clinical symptoms and medical history; CT value indication, prevalence of the disease) would be taken into account.

This instruction did not arouse any interest or resonance in the media, although it would result in a dramatic reduction of the daily case numbers, which would have to lead to the lifting of the imposed 'epidemic situation of national scope'. This would not only render all lockdown measures obsolete, but also the most essential prerequisite for the granting of CMA approval!

Keeping a close eye on the genetic makeup of SARS-CoV-2 is of great importance. In January/February 2020, the DELTA382 variant was temporarily observed. Since early February 2020, the SARS-Cov-2 mutant D614G has been spreading in Europe. It has a higher infectivity. Further variants were added: the British variant B.1.1.7./VUI2020/12/01, known since late September 2020, also appears to be more infectious. The mink mutant (cluster 5. virus) from Denmark (Nov. 2020), the South African N501Y.V2/B.1.351, and the Brazilian variant P.1/P.2 from Manaus complete the spectrum of mutants. The latter resulted in new infections in those already recovered. The efficacy of the vaccine against the already known mutants was not investigated in the studies submitted for approval. The reference strain was the original Wuhan virus.

On tolerance

For any vaccine, good tolerability is absolutely essential, because it is a matter of vaccinating healthy persons and protecting them. Any disproportionate adverse effect on the health of the vaccinated person cannot be justified, especially if it is not a defence against a highly significant risk of disease. Identified adverse reactions (local and systemic reactions named in the instructions for use) are common (up to about 80%), usually mild and transient in character. Unusual was the occurrence of acute facial paralysis and the frequent occurrence of allergic reactions up to anaphylaxis.

Since approval, it has been reported by CDC/USA (12/18/2020) that of 112,807 vaccinees who received a Covid-19 vaccine, 3150 (2.8%) had significant medical conditions that caused incapacity to work as well as medical treatment.

Already at the beginning of the vaccination campaign in Germany (Jan. 17, 2021), the RKI identified 645 suspected cases with 2629 adverse reactions, of which 145 were severe (some with hospitalisation), and 21 of them died. Allergic reactions occurred in 32 cases, including 20 anaphylactic reactions.

Understandably, this does not take into account the lack of long-term experience, which, as a rule, can only bring rare, unexpected events to light.

Vaccine-associated enhanced disease (VAED), including vaccine-associated enhanced respiratory disease (VAERD), is considered a significant potential risk, although these have not been observed in association with Covid-19 vaccination up to the time of licensure. However, it is worth considering that individual Betacorona vaccine studies with SARS-Cov 1 and MERS-CoV elicited immune responses indicative of a VAED. Children who received a vaccine containing inactivated respiratory syncytial viruses experienced exacerbations after infection with this virus type. Therefore, it is reasonable to assume such reactions also for Covid-19 vaccines and to specifically keep an eye on this possibility. They are therefore also the subject of various post-approval studies.

Missing clinical data:

No or absolutely insufficient vaccination knowledge is available for the very elderly (regardless of priority level 1; see above), in persons with dementia, with Down syndrome (priority level 2), or after organ transplantation (level 3), in persons with psychiatric diseases, as well as in immunocompromised persons/immune deficiency, in arrhythmias/atrial fibrillation, HIV, heart failure, apoplexy, in autoimmune diseases, rheumatological diseases, in asthma (all level 4) and allergy sufferers, but also in multimorbid persons. For these, by analogy with pregnant/breastfeeding women and children, until the potential risks of the vaccine have been resolved, vaccination should not be recommended. The same applies to individuals with rare, severe pre-existing conditions.

A differentiated presentation of safety aspects would be desirable for cancer and for persons with chronic kidney disease, chronic liver disease or cerebrovascular disease.

On basic research data:

Missing basic scientific data include those on long-term toxicology including reproductive and genotoxicity, on incorporation of the vaccine into the cell, on what happens when it remains in the extracellular space or is carried away by the lymph,

what happens to the S-proteins produced, where do they go and how are they degraded, how many AK are produced per S-protein, do the S-proteins act as ACE2 receptor agents and if not, why not?

On prioritising:

Linking individual disease risk to vaccination prioritisation is problematic for several reasons. The mRNA vaccine, which is not yet mature, is in itself a risk. Can conflating a vaccine risk, to which every vaccinated person is exposed, with the potentially conceivable infection risk of a prioritised group of persons actually reduce their risk? This is the decisive question that must be answered before individuals in stages 1-4 are subjected to vaccination. Levels 1-4 naturally include, in addition to the very elderly, many multimorbid and highly sensitive persons in need of chronic monitoring, for example, organ transplant patients or immunosuppressed persons, for whom no vaccination experience with ComirnatyR is available. The manufacturer has deliberately avoided including these patients in clinical trials.

Presumably, the risk associated with vaccination is significantly higher for these prioritisation groups compared to healthy younger or non-multimorbid individuals. However, an increase in risk must be avoided at all costs for this group of persons, especially since there are alternatives. Conventional hygiene measures offer effective and risk-free protection, as surgical hygiene measures have always done. The use of the vaccine ComirnatyR, which has not been able to convincingly prevent severe cases of disease and hospitalisations, is just as inadvisable for the very old, co-morbid and multimorbid, in whom no experience at all is available, as it is for pregnant/breastfeeding women and children. This may change as soon as the still missing cognitions and results are submitted.

Comprehensive and objective education of every person to be vaccinated, including up-to-date information on safety and efficacy, is imperative. Advertising, promises of salvation or persuasion are out of place at the present time.

I will talk to you later about that which I have read briefly, when I have read it completely. But now I will go, because Yanarara and Zafenatpaneach have some things to tell you, after which Quetzal will probably still appear. ...

Billy Good-bye, my friend. Farewell, Ptaah.

- 3. The incidence and I wonder if the average citizen even understands what is meant by this term is the number of new infections, that is to say, diseases of a group of persons, which comprises a certain number of persons during a certain period of time, namely calculated on the basis of the number of new infections per 100,000 inhabitants.
- 4. The so-called R-value is used to indicate the reproduction number, which states actually theoretically how many other human beings an infected person continues to infect. If the number of such infections falls below 1, this means

- that the infectious disease, rampantly spreading disease or pandemic is dissipating. Therefore, if on average one infected person infects fewer than one other person, the R-value indicates that the number of infections is declining. However, the R-value is uncertain because it usually indicates the infection incidence of days or weeks that have already passed, that is to say, of a time that already belongs to the past.
- 5. If, in the case of a rampantly spreading disease, the number of active cases, that is to say, the number of acutely ill human beings is looked at, then it is easy to calculate how many of these proven infections lead to deaths. If the number of deaths is then subtracted from the number of those who have survived the rampantly spreading disease and are considered to have recovered, then such resulting figure for all active cases is an important indicator, that is to say, tool for assessing the health system, in which case it must be noted, however, that this value only corresponds to an approximate result, because not all infected persons can be recorded and there is an indeterminable number of unreported cases that cannot be recorded for various reasons for example, if there is no obligation to report recovered persons, wherefore their number is, as a rule, only estimated, consequently, no exact number of active cases comes about.

Due to the irrationality, incompetence and low intelligentum of those in government, who still neither order nor enforce a worldwide travel ban of all kinds, the various new mutations, of which there will also be others, can spread worldwide, as has resulted from the original form since November and December 2019 to the point of the pandemic. Therefore, regarding this the new mutation virus that emerged in the UK will spread very quickly, and by the end of this month of February it will already reach a 30% spread above the corona strain COVID-19 that has been raging since 2019.

But back again to what I already said: one can hear again and again how those without intellect and rationality demand the dismantling of the lockdown measures, therefore as a result the irresponsible ones of the governments arrange relaxations of the whole again, after which the rampantly spreading disease can start anew and again claim many victims. Also, for all possible sensible and nonsensical things, for good and evil, for bad and stupid, as well as for that which is of low intelligentum and clever, there exist some groups, circles, associations and organisations and these know nothing better to do than to incite their members against all necessary safety precautions concerning the rampantly spreading corona disease and thus to spread countless infections, which claim many deaths. As it already happened throughout all the time of the rampantly spreading disease, this is – due to low intelligentum – justified with the fact that already again a decrease of the infections and deaths is taking place, which justifies a relaxation of the measures in this and that case. As I already said, however, low intelligentum and simple-mindedness unfortunately do not know any limitations, and especially not with the governors in the mentioned respect, who are not only as low in intelligentum as bean straw, but besides still, but one must not say this openly. The various parties also play a part in this, each representing different interests and rising up in hostility against the other parties; consequently, constant banter, backtalk and other imbecilic behaviour and quarrels as well as evil unpeace and hatred exist in the government affairs between the parties and produce an unhealthy and unpeaceful climate. Thus on our planet Earth it should be the same as with the Plejaren, that no government parties are

permitted, but that all governors – no matter how many there are – must carry out the government affairs without partisan grouping. In this form alone each member of the government would have to give his/her own personal affirming opinion or non-affirming opinion, according to his/her own ability and discretion, for decisions that arise; namely clearly without any party influence. And this happens then in this form because no party exists; consequently, also no influencing and stipulating of all applications, requests and demands is dictated and demanded, but are absolutely determined by means of self-determination.

However, that which is still to be said or explained now concerning the rampantly spreading corona disease, has already been said since the emergence of the rampantly spreading disease in November 2019, namely also that the rampantly spreading disease was already spreading out from a laboratory in southeast China after the middle of the year 1979, but which you obviously do not know. Thus I still want to explain briefly that the origin leads back to an American,, who, from bare, evil hate joined forces with the Chinese leader Mao Zedong – who was also quite badly ambitious against the USA – in which case a plan was forged to create a deadly virus, which was then to be set adrift in the USA in order to take revenge for something. As I already said in this regard, the first precursor of the virus was released unintentionally already after the mid-1970s, has mutated about 5000 times up to the present time, to then, already from January 2019, in the first rampant form, claim victims world-wide who fell ill, and while many have already died from it, namely without the rampantly spreading disease being recognised, consequently the deaths of many human beings were attributed to other diseases. However, when in November 2019 the coronavirus was spread – as a new and more dangerous mutation – from a secret laboratory in Wuhan in China by infected laboratory technicians, it could very quickly begin to spread all over the world and become a pandemic. This happened while the previous form subsided very quickly and simply dissolved, about which, however, I cannot say anything because I do not know what happened and how that was possible. The coronavirus variation, however, which was already spread in November 2019 and claimed millions of victims, was thus, as I said before, only detected in December 2019, but had already mutated higher again in the same form as before. And this virus, which has already claimed many deaths so far, is expanding the death toll even more, namely by mutating further and becoming more aggressive and more deadly. But to say more about it is also senseless and brings nothing, which is why I want to repeat only some things in relation to all of that which has already been explained several times, but which I will not write down again when I retrieve this passage of conversation again. I want to begin with it

Yanarara Thank you for all your explanations and information which convey to us a clear understanding of the whole of this rampantly spreading Covid-19 disease.
